General Price List

These prices are effective *August 1, 2017*, but may be subject to change without notice.

In compliance with the trade regulations of the Federal Trade Commission (16CFR Part 453); we are required to provide you with this General Price List. The goods and services shown below are those we can provide to our customers. You may choose only the items which you desire. However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of the Funeral Director – This fee, for our basic services, will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains). Our service fee includes, but is not limited to staff responding to the initial request for services; conducting the arrangement conference; planning the funeral; consulting with family and clergy; shelter of the remains; preparing and filing notices; obtaining necessary authorizations and permits; and coordinating with cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our overhead costs including such items as professional licensing, legal and accounting fees, insurance, building and utility expenses, maintenance, taxes, and other administrative expenses. \$ *1300.00

Preparation of the Remains

- 1 **Embalming** – Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial. \$ *575.00
- 2 **Special Care of Autopsied Remains**- This service will provide the cleaning and extra care needed to preserve and restore the appearance for a viewing \$ 200.00
- 3 **Non-Embalming Disinfecting of Remains** \$ 295.00
- 4 **Other Preparation of Remains** – Dressing, casketing, and general application of cosmetics. \$ *150.00
- 5 **Cosmetic Reconstruction** (*per hour*) \$ 125.00
- 6 **Hair Stylist** – This service includes cutting and styling hair. *Tints, coloring and the like are extra.* \$ 65.00
- 7 **Sheltering Remains** (*per-day*) or **Refrigeration** (*per-day*) – Strang Funeral Chapel & Crematorium, Ltd. policy is all non-embalmed remains in our custody will be refrigerated after six hours. Sheltering Remains charge begins on the fifth day of custody of remains. \$ 100.00

Normal viewing or visitation hours are from 4p.m. to 8p.m. Monday thru Friday, and from 1p.m. to 5p.m. on Saturday and Sunday. Our services include visitation set-up, use of visitation room or chapel, placement of encased remains, display of floral arrangements, and supervision and attendant during the visitation.</i>	\$ *600.00
·1 Additional Viewing or Visitation (<i>per hour</i>)	\$ 200.00
Use of Facilities, Funeral Director and Staff for Funeral Service, Ceremony, or Rites at Strang Funeral Chapel (<i>Casketed remains are present.</i>) – Services include coordinating the funeral arrangements, supervision of funeral, staff attendance at the ceremony, supervision of committal or other disposition service, set-up and use of facilities and funeral equipment, and placement of flowers.	\$ *900.00

Alternative Containers – A complete price list will be provided at the funeral chapel ranging in price from \$200 to \$995 .

Cremation Caskets - A complete price list will be provided at the funeral chapel ranging in price from \$995 to \$2500.

Urns – A selection of urns ranging in price from \$25 to \$2,500 is available through the funeral chapel. \$50 urn rental

·7 Receiving Remains From Another Funeral Home – This charge includes transfer of remains from Chicago or Milwaukee airport to funeral chapel, transportation of remains to local cemetery, and necessary services of the funeral director and staff. <i>This charge does not include viewing or visitation (private or public), rites, ceremonies, merchandise, commercial shipping fees, taxes, coroner permits, or “Cash Advance Items”.</i>	\$ 1395.00
·8 Direct Cremation – These services are \$2200. The charge for a direct cremation includes local removal of remains, transportation to the crematory, obtaining necessary authorizations and permits, and the basic services of the funeral director and staff, and the crematory fee. This does not include viewing, visitation (private or public), rites, or ceremonies prior to the cremation, merchandise, commercial shipping fees, or taxes. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials (with or without outside coverings).

·12 Anatomical Gift – This charge includes removal of remains, sheltering and refrigeration of remains, obtaining necessary authorizations and permits, basic services of the funeral director and staff, and transportation of remains to the anatomical gift receiving facility (Chicago only). <i>This charge does not include viewing or visitation (private or public), rites or ceremonies prior to the final disposition, merchandise, commercial shipping fees, taxes, coroner permits, or “Cash Advance Items”.</i>	\$ 1600.00
Mailing of Cremains- This charge includes the packaging and mailing of cremains in an urn to any destination using the US Postal Service (Current market price will be applied)	\$ 60.00
Witnessing of Cremation- This charge includes meeting at the crematorium to have a final viewing of remains if possible through a glass window and witnessing the beginning stages of the cremation.	\$ 100.00

Administrative Fee for Insurance Assignment-This charge includes all necessary phone calls and filing of paperwork in order to assign funds to the funeral bill. \$ 50.00
